



The City of Florissant Unveils Anti-Litter Campaign

Last Fall the City of Florissant announced the roll out of our new anti-litter campaign and held a contest to create the theme and graphics. The winning theme was "Feed the Cans, Not the Land" by Kim Miller and Gary Poenicke created the winning graphic. For their efforts, both won a gift certificate to the Florissant Restaurant of their choice and were recognized at the December 10th, 2018 City Council Meeting.



Signs were ordered and you may have seen the green anti-litter campaign signs posted around the city, in the Independent News or on the City's website. The City will be placing these green anti-litter signs on City Streets and in Parks. We also hope that commercial property owners will display these signs and welcome residents to put them in their yards. The signs are made from the same durable material as the "Drive Like Your Kids Play Here" signs and are available on request (instructions follow).

Backed by the Greater North County Chamber of Commerce, this campaign was dubbed "Florissant's New Year's resolution to reduce litter in our Beautiful City." Voter Identification

The St. Louis County Election Board requires all voters to show some form of identification in order to vote. A government issued photo I.D. is the preferred form of identification because it can be scanned, allowing the lines to move quickly. If you forget your ID, or simply do not have a government issued photo I.D., **YOU CAN STILL VOTE!** However, you will need to either present some other approved form of identification or fill out a provisional ballot and sign a statement confirming your identity.

In general, there are 3 options for showing ID to vote:

Option 1: A Government Issued Photo ID.

Provide a government issued photo ID (e.g. CURRENT Missouri Driver or Non-Driver License, Military ID, US Passport), you can show it to the Poll Worker at your polling place who will process you normally.

Option 2: Secondary form of ID

Provide a secondary form of identification (Voter Registration Card, ID from a MO University or College, Utility Bill, Bank Statement, Government Check, Government document showing your name and address) and sign a statement confirming your identity.

Option 3: No ID

If you have neither of the above IDs, but are a registered voter, you will cast a provisional ballot. Your vote will only be counted if the signature on the ballot matches the signature we have on the Voter Registration file.

Lost I.D. Card

Replacement Voter I.D. Cards may be requested by contacting the Election Board, giving your name and address. New I.D. Cards will be mailed to all voters in each even numbered year, to new voters when they register and to anyone who changes his or her address.

Voter Registration...Who Can Register:

To register to vote, you must meet these qualifications:

- Be a U.S. citizen
- Must be 17.5 years of age (18 years old by Election Day)
- Be a resident of St. Louis County

Where to Register:

There are many locations to register in St. Louis County:
1. *The St. Louis County Election Board located at 725 Northwest Plaza Dr., St. Ann MO, 63074.*

2. Most city halls
3. Most libraries
4. Most schools and Special School District facilities
5. Most local branches of the Junior College District, Universities and Colleges
6. Various businesses, union halls and churches
7. All County Dept. of Motor Vehicle registration offices
8. All State offices providing public assistance while conducting other official business at their establishment.

State election laws also provide for registration by:

1. Mail by going to the Secretary of State's website and requesting an application to be mailed.
2. Online by going to the Secretary of State's website and filling in the application.

When to Notify the Election Board to Update Your Information

- Notify the Election Board if there is a legal name change either in person or in writing.
- Notify the Election Board if there is a change in address either in person or in writing. **ALL** address changes must be submitted to the Election Board by the **4th Wednesday before an election** to make sure you receive your Notice of Election and that you can vote at the correct Polling Place.

IMPORTANT NOTE:

Any person moving into St. Louis County is considered a new registration and must re-register by the deadline date prior to each election. (Example: If you move from St. Louis City to St. Louis County, you must re-register as your City registration does not automatically carry over into a new Jurisdiction.

Please contact the Election Board for any additional registration information by calling (314) 615-1800.

A political party preference is only required when requesting a ballot for a Primary Election.

Historic Properties Available

Florissant derives identity, pride and hope from our shared heritage. We take pride in our rich history and beautiful historic homes and buildings. We want our community to flourish and attract new families who will continue our traditions and preserve our beautiful city. It is with this same conviction that Historic Florissant works toward the protection and preservation of some of the area's historic properties and calls upon the community for a cooperative effort to assure those properties are purchased by owners concerned with historic preservation and who are vested in our community. We call upon persons in the market, to seriously consider a purchase and restoration of these important properties.



The Ouvre-Bellissime House at 359 St. Jean is on the National Register of Historic Places and is listed as an endangered property. This land was once owned by Alexander Bellissime, a French soldier who came over with Lafayette to fight the English in the War of Independence. In 1810, the property was

transferred to Louis and Catherine Ouvre, Florissant pioneers, who built the house shortly thereafter. The home is the first French home to be built of brick. The Ouvre-Bellissime House will be up for auction in the very near future. The current owner is CitiCorp and at this time it is unknown as to what publication will print the auction details. It may be listed by address or by the north quarter block 38 of the New Town of St. Ferdinand. Historic Florissant will post information as their website and Facebook as it becomes available.



This beautiful turn of the century home at 111 St. Catherine was built in 1906. Designated as a local landmark, all exterior changes require a Certificate of Appropriateness by the Landmarks and Historic District Commission. The sale is AS-IS on this three bedroom home. Some interior renovation and updates are needed. The

gorgeous wrap around porch and half acre wooded lot gives a park like feel. With a new roof, 880 square foot garage with a finished office, zoned HVAC, this is truly a special property. The Kramer House at 520 St. Catherine is a fine example of an early French home and needs some TLC. It is perfect for one interested in historic restoration. Without its enclosed porch it has the possibility to look similar to the French home (pictured on the top right). Listed on the National Register of Historic Places, all exterior changes require a Certificate of Appropriateness by the Landmarks and Historic District Commission. This home has 4 spacious bedrooms and two baths. It has a large yard, two car garage and out buildings. This is a Fannie Mae Homepath Property. The City of Florissant's Community Development Office will have applications available for the Home Improvement Program beginning Monday, April 1, 2019. Applications are online at www.florissantmo.com under the Community Development Department tab or in the Community Development Office located in the Government Building at 1055 rue St. Francois.

COMPLETED applications will be accepted Wednesday, May 1, 2019 on a "First-Come-First Serve" basis until all funds have been awarded.

The Home Improvement Program offers forgivable loans to income eligible Florissant homeowners. Applicants must be Florissant homeowners and they must have owned and occupied the house for at least two years prior to application.

Homeowners accepted into the program must remain in their home five years from the date of completion of the program requirements.

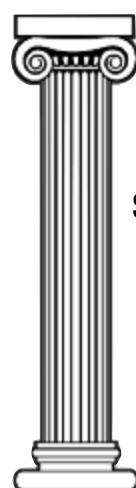

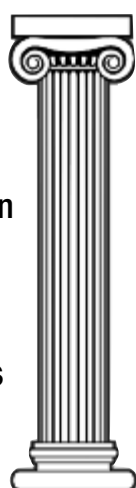

Dear Friends,

It has come to pass that I am writing you my last Mayor's Message for the Florissant Focus. I have decided not to run for a third term as chief executive and will be officially retiring from public office in April when a new Mayor will take the oath of office that I took in 2011 and 2015. I also took the oath of office as a city Council Representative in 1979 and ten more times every 3 years. I have served with Mayor Eagan and Mayor Lowery and 44 Council Representatives either as City Engineer, City Council Representative or as Mayor of Florissant. I have learned valuable lessons from all of them to emulate, to avoid, or both.

Since 1979, first as a Council Representative and since 2011 as Mayor I have always been committed to providing our residents with all of the City services that you deserve and have come to expect. It is amazing how fast 40 years goes by and in the process I became the longest continuous serving elected office holder in the state of Missouri. The way we do business is changing ever more rapidly in this information age but the essentials of dedication, hard work, professionalism, common courtesy and mutual respect will always be valuable.

You inspire me and it has been a great honor and a most fulfilling experience to serve as the Mayor of the oldest and largest City in St. Louis County. I am very grateful for the support that you have given me and my administration. Thank you for putting me in a position to celebrate all that is beautiful about this historic City and to continue to work towards the progress of Florissant, the Metropolitan region and the State of Missouri.

I have been very fortunate to have been surrounded by so many supporters and for having such an outstanding staff that has served under me and those that are currently serving under my Administration. I could not have been successful without the commitment of my Department Heads and all of the dedicated employees who work hard for Florissant each day. I am also very grateful to all of the citizen volunteers who served on our many boards and commissions these past 40+ years.

I am pleased with the progress of the Economic Development in the City during my tenure in office. Major corporations, medical facilities, restaurants, National retailers, and many types of large and small businesses have invested over 200 million dollars and created thousands of jobs in the City of Florissant in the past eight years. A partial list includes the following: Life Care Centers of Florissant, Firestone Service Center, Siteman Cancer Center, 2 CVS Pharmacies, U-Haul Storage Facility, Regions Bank, Aspen Dental, Chic-fil-A, Culver's, Raising Canes, Firehouse Subs, Starbucks, Irma Jeans Family restaurant, Show Me's Sports Bar, Mod Pizza, Popeyes's, McAlister's Deli, Total Urgent Care, Eye Surgery Center, Ashley Furniture, Ulta Salon, Five Below, Michael's, Petco. The list goes

on and our City continues to grow.

I am grateful for the validation that the citizens have bestowed on our leadership by passing Proposition S for Safe Streets maintenance, A&R to establish rental industry fees, Prop B for out of State Car sales, and St. Louis County Prop P to fund Police Protection in Florissant and St. Louis County. (And thankfully the City of St. Louis followed that lead so the entire region is safer).

We have achieved noticeable infrastructure progress in the past 8 years. We converted the energy systems at the large Eagan Center complex to green energy efficient and maintenance efficient systems that will serve us well for many years to come especially for our Ice Rink and Indoor Swimming Pool. We are recommending a building infrastructure upgrade phase two for several other City Buildings as I depart. We have a new state of the art tennis facility at Tower Park, New amenities at our Recreation Centers and many of our parks including major improvements to Manion Park, and in 2019 a renovated St. Ferdinand Lake to enjoy as well as splash pads to be installed at Koch Park and a modern playground to compliment it next year.

We are proud of our new 30,000 square foot state of the art Court Building and Police Annex on Washington Street. With this new court facility Florissant is again setting the standard for all municipalities in St. Louis County, this time on how to create a building dedicated to access to justice. This building is also used to provide needed additional work space and modern meeting rooms for several divisions of our Police Department as well as high tech police training equipment. This building has a digital informational sign which is complimented by two additional digital signs, one at Police Headquarters and one at Koch Park. These signs give the City the ability to make announcements that are urgent or informational about city events.

Our close partnership and mutual respect with the Metropolitan Sewer District, Missouri American Water, Spire Natural Gas, Ameren UE, AT&T and Charter has resulted in Florissant receiving priority status for vital services from these companies. We have benefited from sanitary relief and storm water projects, power line preventative maintenance projects, storm recovery power restoration, water break repairs and restoration and other utility upgrade and maintenance. I thank all of my fellow engineers with all of our utility partners for keeping our electric, gas, water, phones, computers and TVs on.

For over 40 years going all the way back to my City Engineer days I have been an advocate for major bridge construction and the annual and systematic street and sidewalk maintenance. Under my Administration we have been able to add curb and pavement renovation upgrades to our city streets from Proposition S. Also we have established a more aggressive code enforcement division (with your help through Prop

A&R) and a state of the art upgraded Internet Technology Department.

Mayor James J. Eagan hired me in 1976 to work as the Florissant City Engineer and I still remember the first time I walked inside our beautiful City Hall to interview with him at the very same desk I work at daily. I learned many valuable lessons observing Mayor Eagan as a city employee. In addition to working as City Engineer I filled in as Street Superintendent due to that person being ill and after the death of Joe Kiefer I filled in as Public Works Director for several months. Little did I know that these valuable experiences would land me in the Mayor's office.

In 1979 I was elected in a six candidate race to the first of 11 three year terms as the City Council Representative for Ward 3 and served 32 years on the Council. Because of my Engineering background my early Council focus was on public works related projects and every year I used to fight to use Community Development Block Grant money to match MSD and Missouri funds to improve all of the eligible storm water drainage ditches in the city. I also was able to convince the administration and council to continue applying for and matching federal grant money to systematically replace our aging bridge infrastructure.

In 1989 I started the Project Lift - Off Holiday youth Party to help promote our new Drug Awareness and Resistance Education (DARE) program. Some of my most satisfying efforts have been in behalf of the youth of our community to provide good playground and recreation equipment for them to enjoy. One of my favorite pet projects is the Varsity Field at the corner of Charbonier and Howdershell for the use of our teenage athletes to play baseball and soccer on.

There are two words however that describes my top priorities over the years and those are Protection and Progress. I always supported prudent progress promoted by Mayor Eagan and Mayor Lowery but all three of us realized that there could be no progress without protection. Robert G. Lowery, Sr. was appointed Police Chief a few months after I was elected in 1979 and we were always on the same page in regard to giving the police department the resources needed to serve and protect the citizens of Florissant. This priority continued when Chief Lowery was elected to serve as Mayor Lowery after the passing of Mayor Eagan. I was elected Mayor in April of 2011.

Mayor Eagan and Mayor Lowery had different styles and approaches to promoting the progress of Florissant and the surrounding area and I have learned not only from observing their best efforts but also from working with and providing leadership for 44 different council members that I have served with. I used these lessons to maximize our potential to take advantage of every opportunity to attract new investors in our city and to help in any way that I could to promote progress in our region to benefit our citizens.



I felt a call to duty to serve as your Mayor similar to the one that compelled me to join the Navy Seabees (Can Do!) and that feeling became stronger in 2011. I offered my education, experience, accomplishments, and abilities for the voters to review in another six candidate race for the open seat left by retiring Mayor Robert G. Lowery, Sr. I was elected on April 5 and sworn in as the third Mayor under our 1963 Charter on April 25, 2011.

I have always been active in the St. Louis County Municipal League and the Missouri Municipal League as well as the National League of Cities. These organizations educate Municipal leaders on best practices and also advocate for and protect the collective cities in the County, State and Nation. I have testified at many Missouri State Capital hearings and have served on many Municipal league boards as well as serving on a Missouri Task Force.

My education has served me well in life and in the Mayor's office and I encourage our young readers to put a priority on education. I received a degree in Civil Engineering in 1975 from the U of MO Rolla and earned the designation of Certified Financial Planner in 1993. I learned how to use both a Scientific and a Financial Calculator. I am old enough to have known how to use a slide rule which is still a part of the Missouri University of Science and Technology Miner sports mascot. Go Miners!

I have been blessed and honored to continue the vision for the beautiful city and to emphasize the importance of protection, progress and service for the wonderful people of Florissant. With gratitude and warmest personal regards to you and your family I take my leave from public life.

Mayor Thomas P. Schneider Comments On "Better Together" Signature Petition Threat That Would Terminate 233 Years Of Florissant Sovereignty

Florissant is the oldest and largest city in St. Louis County and only St. Genevieve, St. Louis and St. Charles are older in the entire Louisiana Purchase Territory. Founded by the Spanish Governor of the Louisiana Territory in 1786 Florissant is older than St. Louis County, older than State of Missouri, and even a few years older than the Constitution of the United States. We have been a sovereign community under three countries, Spain, France or the United States for 233 years. We appreciate our long history as a sovereign city and wish it to continue for another 233 years.

We would like to continue to be protected by Police who we know and trust. The award winning Florissant Police Department is one of the best law enforcement agencies anywhere and was one of the first to receive the gold standard in public safety, the CALEA certification from The Commission on Accreditation for Law Enforcement Agencies. Other agencies including the County and City Police Departments

have always had the highest respect and have tried to emulate our department. The Florissant Police department is our most valuable asset and is highly appreciated by our residents and is also one of reasons why many investors continue to locate and develop their business in Florissant.

We would prefer to maintain our streets, bridges, sidewalks and other infrastructure rather than surrender it to the Better Together Mega Metro. Florissant has a very proactive Public Works Department which has been validated by our voters with additional revenue to continue proven programs to maintain and systematically rebuild our streets and sidewalks. We are way ahead of the curve compared to the rest of the nation in that we have been systematically replacing our bridges and culverts for more than 40 years ever since I served under Mayor Eagan as City Engineer 1976-1978.

We want to participate in a conversation on how to be a part of a more competitive Metropolitan area but neither myself as Mayor or our City

Council Members were asked by Better Together for our opinions nor were we consulted by the County Executive or the St. Louis Mayor despite the fact that we are acquainted and have been in the same room at the same time many times.

We find it contradictory and puzzling that one day the editorial page of the Post-Dispatch laments the dysfunction of St. Louis City or County or their chief executives or their law enforcement agencies one day and the next day's editorial page proclaims that everyone should happily embrace the idea of a Statewide vote to create a one size fits all mega government controlled by the remotest of leaders.

We think any regional decisions on governance change should be made by the citizens that would be affected. We would be reluctant to entertain the idea of voting to compromise the sovereignty or the method of governing of Rolla, Poplar Bluff, Independence, Springfield, and Hannibal et al. It is hoped that the information in the 160 page Better Together report and other reports such as

the 25 page report prepared by UMSEL's Terry Jones in 2014 entitled "TOWARD REGIONALISM: THE ST. LOUIS APPROACH" and other relevant material such as the written position of SLACMA (St. Louis Area Police Chiefs Association) will be useful to the forthcoming Board of Freeholders.

We support and will participate in the initiative of the Municipal League of Metro St. Louis to collect the necessary signatures to enable a Board of Freeholders (also called Board of Electors) to be formed who will be mandated to hold open public meetings and hearings so that the will of the citizens can be heard in open dialogue and testimony. Open to the public discussions have been a bed rock tradition in our Republic called the United States of America for about as long as Florissant has been a sovereign city.

Chief's Corner

Greetings,

It has been a very busy few months as the Florissant Police Department has not only been responding to and investigating incidents, but as I and several members of the department, participate in a number of events to assist in the betterment of our community. As the Chief of the Florissant Police Department, I speak for the entire department when I say "Thank you" to the Florissant area businesses and organizations that involve us in their community events. I always enjoy the opportunity to speak with residents and to get to know them better.

The police department has been very busy lately with several initiatives that I would like to share with you. The first, was our TEAM Food Pantry Food Drive competition with the Hazelwood Police Department. I truly enjoyed how involved the community got in donating food at several drop off locations. In the end, almost 18,000 pounds of food were donated with Florissant raising slightly more than our friends in Hazelwood. Ultimately, it was the community that won—we all came together for a common goal, and TEAM was given a sizable donation so they can continue their good work.

In December, the Florissant Police Department began our annual Summons of Joy program, where they randomly give gift cards to people who were stopped for minor traffic violations. This program has been growing every year, and we could not do it without several Florissant area churches who raise the money and purchase the gift cards. This year, the churches raised enough funds to purchase sixty-six \$100 gift cards that the Florissant Police Officers gave out to make people's Christmas a little brighter. The Police Department also continued with our 5th Annual Heroes for the Holidays event this December. In this program, started by Officer Lessie Summers, Florissant employees donate funds to purchase Christmas gifts for needy children in Florissant. This year, I am proud to say that enough funds were raised to purchase gifts for fourteen kids, which resulted in one hundred and twenty kids being helped over the five year life of this program. Lastly, the Florissant Police Department teamed up with the Florissant Elks Lodge to do a "Shop with a Cop" for ten needy middle and high school aged children in December. Due to the funds raised by the Elks, each of the kids was given a \$250 gift card to go shopping with one of the members of the Florissant Police Department. I was very fortunate enough to attend this event as the kids went shopping, and to eat breakfast with the families. After speaking with the officers who participated, we all agreed that we felt that we got as much out of the event as the ten children did. Thanks to the Florissant Elks for making ten children's holiday a little brighter.

Since the passage of Proposition P in St. Louis County, I have been working closely with Mayor Schneider and our City Council to use the funds to enhance the department's capabilities in serving our residents. With the Proposition P funds, we have changed the uniformed police employee's pay scale to make it more competitive, which allows for more success at recruitment and retention of quality officers. Recently, the department completed the purchase of a shooting simulator, both mobile and stationary license plate readers, and in car video cameras for our patrol cars—all with Proposition P Funds. The shooting simulator, located at the new Courts Building, allows officers to train in scenarios, which will further improve their decision



making capabilities in high stress situations. I have been present when several community groups utilize the simulator, and the residents leave with a much greater understanding of the difficult decisions that law enforcement officers face. Other items that residents may have seen lately are the License Plate Readers (LPR) that were mounted on two patrol cars, and at stationary locations within the City of Florissant. These LPRs scan license plates as the vehicles pass by, which alerts officers to vehicles that are stolen or wanted. Our investigators can also search the database of scanned license plates and vehicles to assist in the solving of crimes. Lastly, the in-car video cameras were recently purchased after researching several models. These camera systems, which will be installed in all Florissant patrol cars, will increase our transparency with the public.

In closing, I want to thank the public for your willingness to be involved. Whether it is at a community function or reporting a crime, the Citizens of Florissant are what makes this community so great, and we could not do our jobs without you. You are our eyes and ears in the community and we solve a lot of crimes with your help. Please continue to get to know your police department. We offer several programs that allow our residents to get to know the workings of the Florissant Police Department and our officers, and we enjoy doing them. Whether it is the Police Explorer Program for teens, our annual Public Safety Citizens Academy, Neighborhood Watch, CERT, or Coffee with a Cop to name a few, I promise you that you will walk out with a better understanding on the operations of YOUR Florissant Police Department. The programs also allow us to get to know our residents a little better. Please check the Florissant Police Department's website or social media pages for more information on upcoming programs and classes.

Resident Camera Program

Do you currently utilize private video surveillance at your home or business? If you do, we'd like to hear from you.

Video surveillance is one of the best methods for apprehending criminals and convicting suspects who are caught in the act of committing a crime. Installing video surveillance is a great example of community-police partnerships and is something the Florissant Police Department values highly.

How Does it Work?

The Resident Camera Program allows residents and business owners to register locations and capabilities of their security camera systems with the Florissant Police Department. Using this information, when a crime occurs, the Florissant Police Department will know the locations of nearby video cameras and be able to collect video evidence and follow up on leads.

What are the Benefits of Registering your Camera?

Because they are caught in the act of committing the crime, video surveillance is one of the best methods to catch suspects and convict them. As crimes occur nearby, many residents and business owners are unaware that their camera systems may have captured information that could help solve a crime. Likewise, police are not always aware of who may have potentially vital video evidence.

By registering your camera with the Florissant Police Department, officers can quickly identify nearby cameras that may have captured criminal activity. After registering your camera, you will only be contacted by the Florissant Police Department if there is a criminal incident in the vicinity of your security camera and police personnel believe viewing your video footage will assist in the investigation.

If you would like to register your security camera system with the Florissant Police Department and allow officers to contact you should a crime occur in or near where your

Terms and Conditions

The information you provide regarding your camera systems will be for official use only. Your personal information will remain confidential and not be distributed except as required by law or court order. This program is entirely voluntary and you can withdraw consent to view video footage from your camera system at any time by calling the Florissant Bureau of Investigation. If necessary, the Florissant Police Department will contact you directly, using the information provided by you at the time of registration, to request the appropriate video surveillance footage. Any footage containing or related to criminal activity collected by the Florissant Police Department may be used as evidence during any stage of a criminal proceeding. Under no circumstances shall the registrants construe that they are acting as an agent and/or employee of the City of Florissant and/or the Florissant Police Department through the program.

The goal is for citizens to be trained in basic response skills. C.E.R.T. members are then integrated into the emergency capability for their area.

If a natural or man-made disastrous event overwhelms or delays the community's professional response, C.E.R.T. members can assist others by applying the basic response and organizational skills that they learned during training. These skills can help save and sustain lives following a disaster until help arrives. C.E.R.T. skills also apply to daily emergencies.

The application process is open and reservations are being accepted, as seating is limited to 24 participants, for this C.E.R.T. class. Applications will be accepted on a first come first served basis. Applications can be

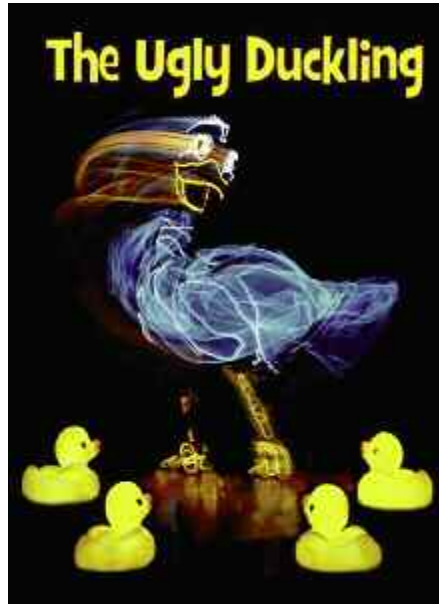

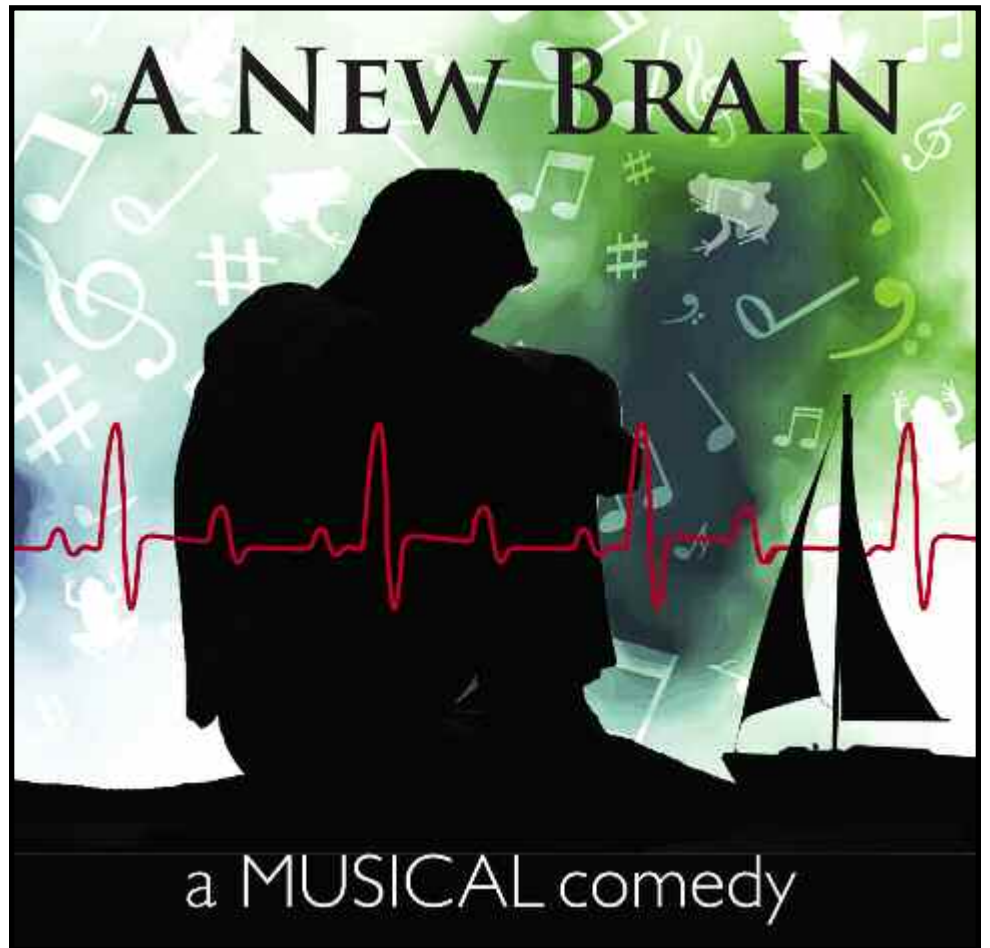

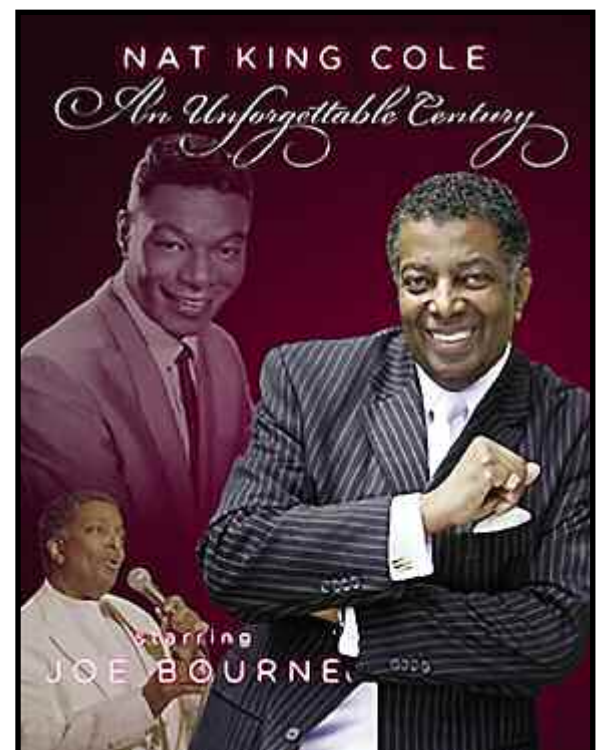

Market Outlook for 2019: Uncertainty is Certain

To say the financial markets were a bit bumpy in 2018 may be an understatement. The S&P 500 was down 6.2 percent for the year, the first time this key index fell since 2008, during the financial crisis. So what can you anticipate in 2019? And what investment moves should you make?

Let's review the causes for last year's market volatility. Generally speaking, uncertainty was a major culprit. Uncertainty about tariffs, uncertainty about the continued trade dispute with China, uncertainty about Brexit - they all combined to make the markets nervous. Furthermore, the Federal Reserve raised interest rates four times, and even though rates remain low by historical standards, the increases caused some concern, as higher borrowing costs can eventually crimp the growth prospects for businesses.

And now that we're into 2019, these same uncertainties remain, so markets are likely to remain volatile. Although the Fed has indicated it may be more cautious with regard to new rate hikes, there are indications of slower growth ahead, particularly in China, the world's second-largest economy. And after strong 2018 earnings growth, helped by the corporate tax cuts, corporate earnings may grow more slowly - and, as always, earnings are a key driver of stock prices.

Nonetheless, the U.S. economy is showing enough strength that a recession does not appear to be on the horizon, which is also likely to be the case globally - and that should be good news, because an extended "bear" market typically does need to be fueled by a recession. Ultimately, the projected continued growth of the U.S. economy and the possible resolution of some uncertainties could help markets rebound.

As investors, we cannot control the everyday ups and downs in the markets, but we can control

our decisions, look for opportunities and keep a long-term perspective within our investment portfolios. Consider these actions for 2019:

Be prepared for volatility. As mentioned, many of the same factors that led to the market upheavals of 2018 are still with us, along with the impact of the partial government shutdown - so don't be surprised to see continued volatility. The more you're prepared for market turbulence, the less startled you'll be when it arrives.

Stay diversified. At any given time, different financial assets may move in different directions: stocks up, bonds down, or vice versa. To help dilute risk and take advantage of different opportunities, you should maintain a broadly diversified portfolio containing stocks, international stocks, bonds, government securities and so on. You may need to rebalance your portfolio to maintain an appropriate proportion of each asset class, based on your risk tolerance and long-term goals. Keep in mind, though, that while diversification can reduce the effects of volatility on your portfolio, it can't guarantee profits or protect against all losses.

Take a long-term perspective. It can be disconcerting to see several-hundred point drops in the stock market. But you can look past short-term events, especially if your most important financial target - a comfortable retirement - is still years or decades away. By keeping your focus on the long term, you can make investment decisions based on your objectives - not your emotions.

If 2019 continues to be volatile, you'll need to stay prepared and make the right moves - so you can be confident that you did everything you could to keep moving toward your financial goals.

Severe Weather Emergency Preparedness Tips

- Prepare a list of kennels, friends and family members who may be able to care for your pet in an emergency
- Pack an emergency kit for your pet as well as enough supplies to last your family members for three days.
- Include a supply of pet food, water and medication along with veterinary records. Don't forget cat litter. To avoid spoilage, rotate your supply of food regularly.
- Make sure identification tags are up to date and securely fastened to your pet's collar.
- It is a good idea to have a photograph of you and your pet, as it can establish ownership if you and your pet become separated.
- A microchip can be important to reunite you with a lost pet if they lose their collar. They may become sheltered in another area outside of your home locale.
