#### **COUNCIL MINUTES**

Monday, January 9, 2023

The Florissant City Council met in regular session at Florissant City Hall, 955 Rue St. Francois on Monday, January 9, 2023 at 7:00 PM with Council President Eagan presiding.

## I. PLEDGE OF ALLEGIANCE

The Chair asked everyone in attendance to stand and join in reciting the Pledge of Allegiance.

## II. ROLL CALL OF MEMBERS

On Roll Call the following Councilmembers were present: O'Donnell, Pagano, Parson, Siam, Harris, Manganelli, Eagan, Caputa, and Schildroth. Also present was Mayor Timothy Lowery, City Clerk Karen Goodwin, and City Attorney Jackie Graves. A quorum being present the Chair stated that the Council Meeting was in session for the transaction of business.

## VI. PUBLIC HEARINGS

- 22-12-026. Request to approve a final subdivision plat of "Lot 12 of St. Ferdinand Commons" for the property located at 3200 N. Hwy 67. (Planning and Zoning postponed the review of this item, therefore the City Council is requested to postpone to the next meeting)

Councilman Eagan moved to postpone Public Hearing No. 22-12-029 to January 23, 2023 to wait for approval of the final subdivision plat, seconded by Manganelli. Motion carried.

23-01-001. Request to authorize a Special Use Permit to Krystal Smith d/b/a Krissy's for the locacation of a sit-down, carry-out, drive-thru restaurant located at 2470 N. Hwy 67. (Planning and Zoning Commission recommended approval on 12/5/2022)

The City Clerk reported that Public Hearing No. 23-01-001 for the Request to authorize a Special Use Permit to Krystal Smith d/b/a Krissy's for the location of a sit-down, carry-out, drive-thru restaurant located at 2470 N.Hwy 67. The Chair declared the Public Hearing open.

Krystal Smith, owner, stated she has been in business for about 3 years specializing in funnel cakes, homemade ice cream, and other snack foods as well as burgers and chicken strips. She noted Serendipity Ice Cream in Webster Groves makes the homemade ice cream. Ms. Smith noted about 12-16 guests would be able to sit inside the building and she plans to update the dumpster enclosure for the property. She stated the hours of operation would be 11am to 8pm 7 days a week with a sign on the exterior building. Ms. Smith is hoping to have the business open and operating by February. The current location on Parker Road is on a month-to-month lease and she intends to close the location once she has approval in Florissant.

Being no further comments, Councilman Siam moved to close the Public Hearing, seconded by Harris. Motion carried.

23-01-002. Request to authorize an amendment to B-5 ordinance no. 6266 to add "Educational Development Center" as a permitted use at 3180 N. Hwy 67 (Goodwill Excel Center). (Planning and Zoning recommended approval on 12/5/2022).

The City Clerk reported that Public Hearing No. 23-01-002 for the Request to authorize an amendment to B-5 ordinance no. 6266 to add "Educational Development Center" as a permitted use at 3180 N. Hwy 67. The Chair declared the Public Hearing open.

Mark Aarons, President and CEO of MERS Goodwill, noted the business is opening an adult high school which would serve about 200 adults to allow for them to finish their high school diploma and pick up where they left off in school. Mr. Aarons stated they offer an on-site preschool, certifications, and life coaching. He noted classes are 8:30am to 8:30pm Monday through Thursday with a maximum of 6 classes per day operating year-round and tutoring on Fridays and it would be the 6th location to be opened in Missouri. Mr. Aarons stated about 120 students could be in the building at the time and the business is hoping to be open by March 20, 2023. The minimum age for students is 21 and over since Missouri schools can no longer accept students over the age of 21. Mr. Aarons noted the education center does have 504 accomodations, but transportation would not be provided but the school does assist with students finding others who can carpool. He clarified there is no cost to students for their education or certifications and the funding is completely provided through the State. Mr. Aarons noted the Excel Center partners with shelters to provide food at home for families though food is not provided at the center for lunches. He stated the success rate is about 30% higher than a non-high school graduate as far as income and about 780 individuals have graduated in the last 3 years.

Being no further comments, Councilman Siam moved to close the Public Hearing, seconded by Schildroth. Motion carried.

23-01-003. Request to authorize a B-5 "Planned Commercial District" to allow for a grocery store located at 182/240 Howdershell (Aldi). (Planning and Zoning recommended approval on 12/5/2022)

The City Clerk reported that Public Hearing No. 23-01-003 for the Request to authorize a B-5 "Planned Commercial District" to allow for a grocery store located at 182/240 Howdershell. The Chair declared the Public Hearing open.

Brandon Harp, engineer, noted the two parcels are going to be consolidated to be made into the grocery store location. He noted the current driveway would be used and the legal team is currently working to relocate the access easement and the trash enclosure for Dairy Queen. The building will have a single dock for the unloading trucks and a proposed potential expansion if the building would need expansion. He noted the building would have proper screening for the residents and a recessed trash enclosure and not visible to the public. Mr. Harp noted they would like to have a post sign which is a 9 ft by 6 ft flat panel sign at approximately 30ft tall. Additionally, there would be signs at either side of the entrance to the building. Mr. Harp noted no scheduled time for trucks coming to

unload, but it would be a single truck at any time rather than multiple trucks throughout the day and night.

Being no further comments, Councilman Eagan moved to close the Public Hearing, seconded by O'Donnell. Motion carried.

Patrick Mulcahy, Economic Development Director, noted Retail Strategies is a company which works with cities around Missouri to help better market themselves and with the contract, the company will help Florissant to attract certain companies to open within Florissant. He noted the city will let the company know which businesses the city desires and will take a tour around the city to find commercial properties which are available. Mr. Mulcahy stated based on national trends, Retail Services will let the city know which companies they can attract based on the tour and request as well as selecting sites for specific types of retailers. He noted the contract includes offering data throughout their service and comparing data to peer cities which are similar to Florissant. Retail Strategies will provide contact information for who to market to and continue communication with the Economic Development Department and Mayor Lowery as well as a website for city to check on progress. The company will also represent the city at national conferences and market the city. On roll call the Council voted as follows:

He noted the council needs reassurance the owner will follow the ordinance requirements and the laws within the city. He noted concerns with a nightclub type uses within the business and is concerned of the safety of residents, patrons, and others. Prince Koroma, owner, noted he is not operating a nightclub, but a restaurant and bar to give people a more upscale spot to watch sports and eat. He stated the LLC name was because of his mobile Hookah business he previously had and did not realize he would not be allowed to have hookah when originally opening in Florissant. He noted he has since put away all the hookah at his location and will not be allowing use inside the building. The request was approved as follows:
