# SUBSTANTIAL AMENDMENT #2 TO THE FY2019 ANNUAL ACTION PLAN COMMUNITY DEVELOPMENT BLOCK GRANT – CORONAVIRUS FUNDS

#### **Public Review**

Pursuant to HUD regulations, the City of Florissant's Citizen Participation Plan and current HUD waivers for grant programs and consolidated plan requirements to prevent the spread of COVID-19, staff published a 15-day public notice and 30-day comment period. Public comments and will be included in the Substantial Amendment to the FY2019 Annual Action Plan.

PUBLIC NOTICE IS HEREBY GIVEN that a Public Hearing will be held on Friday, January 24, 2025, at 4:30pm at the Florissant Government Building, 1055 rue St Francois, concerning the proposed Substantial Amendment to the Fiscal Year 2019 Community Development Block Grant – Coronavirus (CDBG-CV) Annual Plan.

A draft of the plan will be available for review on the City's website or the Florissant Community Development Office (314.839.7680). A 30-day COMMENT PERIOD will begin Saturday, January 25, 2025, and will end at 5 p.m. on Sunday, February 23, 2025.

The City of Florissant is recommending to re-allocate the funds as follows:

## FY2019 CDBG-CV

The City of Florissant recommends re-allocating \$28,243.80 from the MRU-Assist Program and \$94,311.03 from the Administration program for a total of \$122,554.83 to a new Public Facilities program.

The **MRU-Assist** program was to provide income eligible, City of Florissant residents with financial assistance for household rent, mortgage or utility assistance to reduce foreclosures, evictions, utility shutoffs, and to prevent dislocation and homelessness due to the increased need and demand due to the impact of COVID-19. And the **Administration** funds were utilized to administer CDBG-CV funding. These programs no longer hold a high priority.

After the re-assessment of funding priorities, it was decided to reallocate the \$28,243.80 from Administration and the \$94,311.03 from the MRU-Assist Program to the **Public Facilities-Police Station/Jail.** These funds will aid with the repair/replacement of the HVAC system at the Police Station/Jail and will benefit this public facility by improving air quality and reduce airborne transmissions thereby reducing the risk of exposure or contraction of the virus. This use of funds will help slow or avoid further spread of disease, and prevents future spread.
