Storm Related Information



Our area was hit with severe weather on Friday, March 14<sup>th</sup>. The impact is extreme, and cleanup efforts have been tirelessly going on since the storm hit on Friday. The Florissant Police Department is actively patrolling neighborhoods and working alongside emergency responders, utility workers, and city crews to ensure public safety.

City staff has been working extremely hard and helping anyway they can.

**DIAL 211 TO REPORT** - We are asking that Florissant residents dial 211 to report storm-related damage. As we navigate this challenging time, we urge everyone to remain cautious and please be aware of scams and fraudulent contractors.

**CALL PUBLIC WORKS** - City of Florissant is also working to provide dumpsters in the areas most affected by the storms. These dumpsters are intended for storm-related debris such as damaged property (e.g., shingles, furniture, and similar items). Please note that tree limbs and yard debris should not be placed in these dumpsters. Crews will patrol neighborhoods for limbs, but it would be helpful to call public works at 314-839-7652, or email [JTimme@florissantmo.com](mailto:JTimme@florissantmo.com).

The Florissant Police Department, Public Works Department, and Media Department have all been working diligently to document the damage done to Florissant homes and businesses from the March 14th tornado that hit Florissant. The City of Florissant does this for important documentation purposes. With the large spread of this storm, there will be some houses or areas that were damaged that we missed, were unable to see from the street, or we just haven't been able to document as of yet.

This documentation process is for the purpose of providing the State of Missouri, St. Louis County and other agencies the most accurate damage information and to make sure Florissant gets the support and assistance that we need.
