
- Being highlighted on Florissant's City Web site as a Cool City Business.

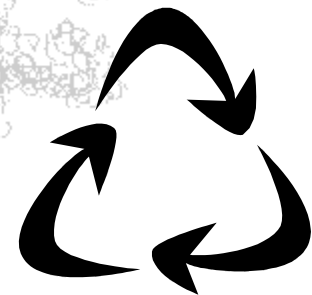
